7. Other Business	<p>M & C Redding & G Dodd had the opportunity to visit the Northparkes mines with R Laufmann and R Sawers. This was a beneficial opportunity for them to meet local landowners and townspeople and ask questions. C Redding noted they have only just come back and please don't take this as an extensive presentation/feedback but initial impressions and some points of interest are:</p> <ul style="list-style-type: none"> • We look forward to seeing the comparison that is being prepared by Rex between Northparkes and Hillside eg size, so as to gauge possible inferences and implications for Hillside and the community. • Relationship between neighbouring farmers and mine was based on shared benefits. All neighbours given opportunity, and many have taken up the opportunity to farm land not used by mine. The mine constantly it (appeared to the farmers) to be drilling on their property, for example: when a piece of mine equipment got bogged on farmer's land (not sure if their land or mine's) the farmer used his equipment to get them out. • When meeting with farmers at their (Northparkes' mine) BBQ it appeared both parties used the opportunity to genuinely enquire / establish / confirm ties / arrangements. Wasn't just a tick box consultation! The Mine Manager meets with farmers twice yearly • Layout of mine infrastructure was sprawling and industrial which we as farmers found difficult to comprehend as a land use as mining is foreign to us. • Northparkes started operating in the 60's on 15,000 acres. 10,000 acres of this area is being farmed by neighbouring farmers and the companies Farm Manager. This land is also used as a buffer between the mine and neighbouring landowners. • Nearest house is 2-3km's away • There are 4 tailings dams. Only one is used at a time with sometimes dust issues on the other 3 while they are not in use – viewed the sowing of plants directly into the tailings surface in unused dams to prevent dust • Met random townspeople who responded positively towards the mine • The harmony between neighbouring landowners and the mine depended largely on the Mine Manager • Community volunteer days set aside and the mine encourages their staff to participate • Landowners mentioned there was increased traffic flow so they just avoided coming into town during shift change • Have a community group similar to HMCV
