Letitia Dahl-helm sent out the invitation via email before the meeting to advise members of the workshops (held Friday 6 – Sunday 8 September).

ITEM 4

4.1 Status of Section One Hickeys Point to Corny Point

Letitia advised the Working Party that after the first round of public consultation for Section One, some amendments were made to the Strategy and subsequently a second round of public consultation was conducted.

Submissions from the second round of publication consultation will be summarised and recommended amendments reported to Council for endorsement or otherwise, at a meeting in the future. Some of the submissions relate to Crown Land and the Community Land Management Plan, therefore requiring consultation with the Crown Lands Office (ongoing).

4.2 Progress of Section Two Corny Point to Council border, Cape Elizabeth

Deb Furbank advised the Working Party that work on Section Two has commenced. Eighty nine (89) land parcels of community land (either owned by Council or in Council's care, control and management) have been identified. Threatened species data has been received from the Department for Environment and Water. The consultant Sonia Croft has been engaged to undertake BushRAT surveys for twenty-four (24) parcels of land, which has recently commenced.

Deb led a discussion about possible contentious issues for Section Two, so the Working Party could be well aware of them. These will be discussed with relevant community groups and Progress Associations so they can have input into the drafting of the related recommendations in the Strategy, prior to public consultation.

4.3 Section Two Public Consultation Planning

Deb advised the Working Party that the intent is for one round of public consultation, rather than two, on the Draft Strategy for Section Two. However if submissions are made that require major changes to the document it is recommended a second round occur, which was agreed to by the Working Party.

Deb will meet with Progress Associations, community groups and any individuals who have special interest in any of the areas in Section Two.

The locations that have been suggested for the public consultation workshops are Corny Point, Minlaton and Port Victoria. The Working Party agreed that these are appropriate locations.

4.4 Northern and Yorke Coastal Management Action Plan - update

Stephen Goldsworthy advised the Working Party that the Coastal Assessment of the Northern and Yorke Coast Report was developed a few years ago however no actions were put in place. Natural Resources Northern and Yorke are working with Legatus and Greening Australia to develop a Northern and Yorke Coastal Management Action Plan. Stephen provided the Working Party with an overview of the current status of this plan development.

ITEM 5 GENERAL BUSINESS

Letitia Dahl-helm recommended to the Working Party that minor changes be made to the Terms of Reference in regards to the quorum for the Working Party. Edits will be made to the Terms of Reference and provided at the next meeting for review and endorsement.

Cr Naomi Bittner suggested that due to most of the Working Party members located the northern end of the Council area, future meetings be held at the Maitland Office, on a day and time that suits the members.

Cr Roger Johns highlighted the coastal hazard issues around Balgowan.
