4.1 <u>Review of Public Consultation for Section Two: Corny Point to Council Border</u> (The Gap)

4.2 Crown Land Coastal Management

Letitia provided an update on the submission to the Coastal Council Alliance in regards to Crown Land management.

4.3 <u>Update on progress of Section Three: Council Border (Federation Park) to</u> <u>Hickey's Point</u>

Deb provided an update on the progress of Section Three stating that a consultant has commenced the BushRAT surveys and there is already community interest in this section.

4.4 Outcome of Local Roads and Community Infrastructure Program

Council endorsed \$100,000 of the Local Roads and Community Infrastructure Program fund to deliver works from the Draft Coastal Management Strategy's. This has been submitted to the Australian Government for approval.

Northern and Yorke Landscape South Australia have dedicated \$100,000 towards projects that implement their Coastal Management Action Plan. Council have submitted an expression of interest for \$60,000 to deliver works in their high priority areas.
