



R001- EXTRACT OF ELECTED MEMBERS' REGISTER OF INTERESTS

Under section 70(a1) of the *Local Government Act 1999*, the council must publish on the website, the following details about a council member as recorded in the Register of interests:

- the member's income sources (within the meaning of Schedule 3 to the Local Government Act) or employer;
- the name of any political party, anybody or association formed for political purposes or any trade or professional organisation (within the meaning of Schedule 3) of which the member is a member;
