To seek endorsement of a package of projects to be undertaken using the Local Roads and Community Infrastructure Program – Phase 3 funding.

**RECOMMENDATION**

That Council

1. endorse the CEO to apply for projects under the Australian Government's Local Roads and Community Infrastructure Program;
2. endorse the projects (as listed below) to be nominated in the Work Schedule Template – Project nomination form:
  - a) Various township road reseals (\$500,000)
  - b) Arthurton – Main Street beautification (\$200,000)
  - c) Maitland – Installation of spill ways – Maitland West Terrace (western) dam (\$80,000)
  - d) Minlaton Rest Centre exterior upgrades (replace gutters and paint exterior) (\$25,000)
  - e) Various walking trail upgrades (\$50,000)
  - f) Installation of toilets at two bush camping locations (\$80,000)
  - g) Yorketown – Salt lake tourist trail upgrades (\$50,000)
  - h) Hardwicke Bay – Lookout and shelter – boat ramp car park (\$50,000)
  - i) Corny Point – Creation of Corny Point township walking trail (Walk the Yorke) (\$50,000)
  - j) Port Victoria – Installation of new barbecues (\$14,000)
  - k) Balgowan – Installation of playground shelter (\$8,000)
  - l) Port Moorowie – Installation of two beach shelters (\$25,000)
  - m) Port Victoria – boat ramp car park extension (\$50,000)
  - n) Ardrossan – clifftop playground equipment upgrade (\$88,000)
  - o) Port Julia – campground road upgrade (\$20,000)
  - p) Various Coastal Management Strategy Projects (\$200,000)
  - q) Edithburgh – Jetty stone seawall repairs (\$25,000)
  - r) Marion Bay – User pays system upgrade – desalination plant (\$45,000)
  - s) Various Southern Yorke Peninsula water tower upgrades (\$40,000)
  - t) Bublacowie & Wool Bay - Southern Yorke Peninsula water tower extension project (\$130,000)
  - u) Maitland – Town Hall upgrades (\$18,000)
  - v) Stansbury – Grandstand repairs (\$65,000)
  - w) Ardrossan – Town Hall salt damp repairs (\$13,000)
  - x) Stansbury – Cemetery fence replacement (\$15,000)



- y) Minlaton – Town Hall replace existing fire panel (\$80,000)
- z) Corny Point – Corny Point hall ceiling and window repairs (\$10,000)
- aa) Port Vincent – Disability access to Institute (\$50,000)
- bb) Yorketown – Area School entrance upgrade (\$20,000)

### LINK TO STRATEGIC PLAN

**Goal:** 1 Economically Prosperous Peninsula

### BACKGROUND

On 22 May 2020 the Australian Government announced a new \$500 million Local Roads and Community Infrastructure Program (LRCI Program). Through the 2020–21 Budget, the Australian Government announced a \$1 billion extension of the LRCI Program, following strong community and local government support.

This program is designed to support local councils in delivering priority local road and community infrastructure projects, supporting jobs and the resilience of local economies to help communities bounce back from the COVID-19 pandemic. LRCI Program Phase 3 will continue to support local jobs and businesses.

From 1 January 2022, council will be able to access funding through LRCI Program Phase 3, with projects under the Program to be delivered by 30 June 2023.

The increased funding available under LRCI Program Phase 3, as well as a longer delivery window, will allow Council to pursue larger, more complex projects that may be a higher priority and have a bigger impact on our community.

### DISCUSSION

Funding under the LRCI Program Phase 3 is determined by formula, taking into consideration road length and population, using this formula Yorke Peninsula Council will receive a grant of \$1,807,828 (excluding GST).

Yorke Peninsula Council is required to nominate projects to be undertaken under the LRCI Program Phase 3.

Eligible projects may include:

- Eligible local road projects - projects that involve the construction or maintenance of roads managed by Council. Council is encouraged to consider how works can support improved road safety outcomes. This could include projects involving any of the following associated with a road:
  - traffic signs
  - traffic control equipment
  - street lighting equipment
  - a bridge or tunnel
  - a facility off the road used by heavy vehicles in connection with travel on the road (for example, a rest area or weigh station)
  - facilities off the road that support the visitor economy
  - road and sidewalk maintenance, where additional to normal capital works schedules.

- Eligible community infrastructure projects are projects that involve the construction, maintenance and/or improvements to council-owned assets (including natural assets) that are generally accessible to the public.

All projects whether carried out on council owned land, or another type of public land, must deliver benefits to the community, such as improved accessibility, visual amenity, and/or safety. Examples of eligible works include:

- Closed Circuit TV (CCTV)
  - bicycle and walking paths
  - painting or improvements to community facilities
  - repairing and replacing fencing
  - improved accessibility of community facilities and areas
  - landscaping improvements, such as tree planting and beautification of roundabouts
  - picnic shelters or barbeque facilities at community parks
  - community/public art associated with an Eligible Project (Eligible Funding Recipients will need to provide a clear description of the conceptual basis of the artwork)
  - playgrounds and skate parks (including all ability playgrounds)
  - noise and vibration mitigation measures
  - off-road car parks (such as those at sporting grounds or parks)
- Other Public Land Projects – Projects that involve the construction, maintenance and/or improvements to state/territory and Crown owned land/assets, and Commonwealth owned land/assets, can also be eligible projects where the Council can confirm that they have the authority of the land or asset owner to undertake the project at the nominated site(s) and the site(s) are accessible to the public (including natural assets).

The intent of the funding is that Eligible Funding Recipients undertake infrastructure projects which are additional to projects that they had planned to undertake using either their own funds or funds already available to the Eligible Funding Recipients by another opportunity. The funding is not intended to replace existing expenditure commitments but rather to enable further, additional expenditure as economic stimulus.

Staff and Elected Members have reviewed the Elected Projects. Staff advocate the projects as listed in the recommendation. These projects strongly meet eligibility criteria and staff are confident these projects will be approved.

## **COMMUNITY ENGAGEMENT PLAN**

### Level 3 - Participate

Council proactively consulted with every Progress Association within the Council region, asking each for project proposals to be considered for funding via the Local Roads and Community Infrastructure Program (LRCI Program) – Phase 3.

Progress Associations were asked to list their project proposals in priority order, and indicate whether they were willing to make any co-contributions. Council also sought costings and other information for Progress-driven project suggestions when requested.

This consultation resulted in numerous project ideas, including 10 which have been recommended for approval in this report. Including co-contributions, Council has been able to turn the \$1,807,828 of LRCI Program funding into over \$2,000,000 of total community value.
