The Panel sought clarification from the Applicant and Planning Officer, Susan Hadley, in relation to the onsite parking.

9.49am Applicant Matthew Hodge concluded is address to the Panel.

9.51am Ashley Mehmet addressed the Panel and raised concerns in relation to the dwelling which he believes to be a duplex, the lack of proposed onsite parking for a dwelling of its size, and the positioning of the bins. He stated his concerns, that inadequate onsite parking would subsequently lead to offsite parking along Cardigan Castle Circuit and instigate him to request yellow lines (no parking) be applied along Cardigan Castle Circuit.

Discussion ensued and the Panel sought clarification from the Planning Officer, Susan Hadley and Ashley Mehmet in relation to some of the concerns raised.
