4	Feedback from the Working Party – Draft Heavy Vehicle Access Strategy (DHVAS)		
	AMK explained the aim of DHVAS's "Annexure 9- Primary producer rates versus rates expenditure", was to provide an overall indication of apparent inequity that needed to be considered in the future. The annexure looked at the percentage of budget allocated to roads benefiting primary production versus percentage of the rate pool contributed by primary producers. The RWP discussed how to raise extra funds into the future (ie introduce new tiered rate to include Extractive Industries).		
	Next steps will be to put to Council to endorse, seek community feedback then back to Council with strategy planning for approving.
