Explanatory Notes

- 1.2 The return period for the purposes of this return is as follows:
 - if your last return was a primary return under the Act the period between the date of the primary return and 30 June next following:
 - in any other case the period of 12 months expiring on 30 June, or within 60 days after 30 June in any year.
- 2.1 Under the Act, income source, in relation to a person, means:
 - any person or body of persons with whom the person entered into a contract of service or held any paid office; and
 - any trade, vocation, business or profession engaged in by the person.
- 2.2 Under the Act, financial benefit, in relation to a person, means:
 - any remuneration, fee or other pecuniary sum exceeding \$1,000 received by the person in respect of a contract of service entered into, or paid office held by, the person; and
 - the total of all remuneration, fees or other pecuniary sums received by the person in respect of a trade, profession, business or vocation engaged in by the person where that total exceeds \$1,000

but does not include an annual allowance, fees, expenses or other financial benefit payable to the person under the Act.

- 3.1 Under the Act, a designated person or entity, in relation to a member of a council, means:
 - a member of the member's family; or
 - b) a family company of the member; or
 - a trustee of a family trust of the member.
- 3.2 A family company of a member means a proprietary company:
 - a) in which the member or a member of the member's family is a shareholder; and
 - b) in respect of which the member or a member of the member's family, or any such persons together, are in a position to cast, or control the casting or, more than onehalf of the maximum number of votes that might be cast at a general meeting of the company.

- 3.3 A family trust of a member means a trust (other than a testamentary trust);
 - a) of which the member or a member of the member's family is a beneficiary; and
 - which is established or administered wholly or substantially in the interests of the member or a member of the member's family, or any such persons together.
- Under the Act, family, in relation to a member, means;
 - a) a spouse or domestic partner of the member; and
 - a child or stepchild of the member.
- 5. For the purpose of this return, a person is an investor in a body if:
 - the person has deposited money with, or lent money to, the body that has not been repaid and the amount not repaid equals or exceeds \$10,000; or
 - b) the person holds, or has a beneficial interest in, shares in, or debentures of, the body or a policy of life insurance issued by the body.
- Under the Act, trade or professional organisation means a body, corporate or unincorporate, of:
 - a) employers or employees; or
 - b) persons engaged in a profession, trade or other occupation.

being a body of which the object, or 1 of the objects, in the furtherance of its own professional, industrial or economic interest or those of any of its members.

- Under the Act, beneficial interest in property includes a right to re-acquire the property.
- Under the Act, relative of a person means:
 - (a) the spouse or domestic partner; or
 - (b) a parent, step parent or remoter lineal ancestor; or
 - (c) a child, step child or remoter descendant; or
 - a sibling or step sibling; or
 - (e) any member of the person's family who resides in the person's household.
- Under the Act, a person's residential address or any other address suppressed under Section 68(4)(a) must not be published and have been redacted.
