#### ITEM 2 CORRESPONDENCE

2.1 Correspondence (23/88669) dated 15 September 2023, from Ardrossan Progress Association (APA) requesting financial assistance for a disability accessible table and chair setting to be located at the new pump track, Second Street, Ardrossan (on the old tennis court). At the 27 October 2023 Access Advisory Working Party meeting the Working Party indicated in principle support pending the outcome of insurance being obtained for the pump track. The quote provided for the table setting is \$1,750 (including GST). The APA are offering a \$200 contribution and in kind support by way of installing the setting, therefore the APA is requesting a financial contribution of \$1,550 (including GST).

2.2 Correspondence (23/91145) dated 21 September 2023 from the Yorketown Progress Association (YPA) on behalf of the SYP Community Hub, Yorketown, requesting financial assistance for the replacement of the front double timber doors on the SYP Community Hub building. A quote of \$6,278 (including GST) was presented at the 27 October 2023 Access Advisory Working Party meeting and it was determined that a second quote be sought for the proposed project, which should include removing the raised lip in the doorway. 

**Attention: Access Committee Working Party** 

To whom it may concern,

We write on behalf of the SYP Community Hub, who are working to improve the accessibility of their services.

The SYP Community Hub is based at the old Yorketown School building, 33 Stansbury Rd Yorketown. The building is YP Council owned, with the SYP Community Hub operations and employees supported by a voluntary committee. The SYP Community Hub provides many essential services to the community. These include Centrelink and Service SA agent support, outreach programs operate from the Hub, printing and laminating, digital technology assistance, computer classes, Salt Lakes gallery and Tourist Information Centre, various workshops, community resilience and youth worker programs. The SYP Community Hub is community-led, taking an active role in supporting individuals to access the services they require and responding to community need wherever possible.

While the building retains many features that were part of the original build, the heavy and cumbersome front entrance doors have been identified as a priority for improvement. The doorway consists of two narrow (600mm) doors. One door remains bolted shut the majority of the time, with the second door acting as the front entrance to the Hub. There are also screen doors in the same formation on the outside of the heavy wooden doors.

Staff and volunteers at the SYP Community Hub often need to unbolt both the second screen door and second heavy wooden door to allow access to any clients requiring a wheelchair, walker or prams etc. This can be a tedious process, particularly as some staff cannot reach the latches and bolts. We feel this causes unnecessary embarrassment and frustration for both clients wishing to utilise our services, as well as staff. This is exacerbated when clients are left waiting in bad weather for a staff member to see they are struggling to enter the centre. Staff are concerned the lack of accessibility may prevent some community members from feeling welcome and accessing our services.

We have obtained quotes to replace the existing wooden and screen doors with a singular glass and aluminium frame door that is easy for both clients and staff to open (with the added feature of hold open and limit stop functions to improve accessibility). The glass doorway will also improve safety for staff as they can easily see who is entering the building and improve the natural light entering the space making our entrance feel warm, welcoming and inviting.

The SYP Community Hub requests \$6,278.00 to complete the refurbishment of the front entrance with
accessibility of our most vulnerable community members front of mind. We thank the Access Committee
Working Party for their time and consideration of the SYP Community Hub's proposal to improve access of
the front doorway entrance.

The Minlaton and District Progress Association would like to raise two issues for discussion at the October meeting of the Access Advisory Committee.

The first is the lack of a crossing on the North end of Minlaton's Main Street between the Dental Surgery and the Service Station.

The second being the poor state of the footpath on the corner of North and West Terrace adjacent the School crossing. The footpath is very uneven and hence unsafe for the many users; being pedestrian, cyclists and parents with prams or pushers.

The first issue may need discussion on-site between Council and Progress personnel and perhaps the adjacent business. The second may be able to be fixed within the maintenance budget.

#### **Good Morning Maddy**

The Ardrossan Progress Association has two items they would like to request the Access committee add to the agenda of their next meeting.

- 1 At the entrance to the World war one memorial garden there is a 3cm step up into the garden. We noticed at the recent memorial service that this step caused difficulties for those with walking frames. Wheel chairs and gophers as they couldn't get up the step without assistance and in some cases couldn't get up at all.
- 2 At the gate to the Pump track the gravel pathway is soft and not compactable. This loose gravel is making a hollow area near the concrete across the gate. Theis loose gravel and the resulting hollow area makes it difficult for wheeled chairs and gophers to get through this gateway.
