Notes & Disclaimers

General

Certain fees and charges listed (and appropriately identified) in this document are determined by legislation and are therefore not set by Council. These statutory rates are updated as soon as possible following updates to relevant legislation and notification to Council of these updates. Where a variance is found to exist between the actual statutory fee or charge and that published in Council's register the actual statutory fee or charge will take precedence.

Caravan Parks

These are maximum standard charges. Individual parks may offer special rates and promotions subject to approval from the CEO or nominated Council officer. For powered sites

Peak season rates apply between December 13th and January 26th . Shoulder season rates apply between 27th January - 30th April and 13th October- 12th December, Off-peak season rates apply Between 1st May - 26th September.

Fees are increased one step (from off-peak to shoulder, or from shoulder to peak) during long weekends and school holidays. These dates for 2024-25 are:

School holidays:

- 5 - 21 July 2024 (shoulder rate)
- 27 September to 13 October 2024 (peak rate)
- 11-27 April 2025 inclusive (peak rate)
- 13 Dec 2024 -26th January 2025 (peak rate)

Long weekends:

- 4-7 October 2024 (peak rate)
- 24-27 January 2025 (peak rate)
- 7-9 March 2025 (peak rate)
- 17-21 April 2025 (peak rate)
- 24-26 April 2025 (peak rate)
- 6-8 June 2025 (shoulder rate)

School Holidays and Long weekend rates will raise to Peak, excluding those that occur during the months of June and July which will raise to Shoulder.

Bookings during long weekend and School Holidays may incur a minimum stay requirement, please contact the caravan park direct to confirm booking requirements, single night accommodation may be available based on the parks management discretion. Cabin prices quoted are for 2 persons only unless specified, additional charges will be incurred for any additional guests and linen kits . Maximum of 6 persons per site.

Waste and Recycling - Resource Recovery Centre

All gate fees collected are retained by the Contractor maintaining the Resource Recovery Centre on behalf of Council as per conditions of the contract. Gate fees are subject to change at short notice as a result of changes in the Solid Waste Levy and EPA charges which are passed onto Council by the contractor. This may mean that the fees adopted by Council in this schedule may not be the same as those charged at the Resource Recovery Centre. The schedule will reflect the most recent fees as far as practicable.
