### ITEM 3 <u>DEVELOPMENT APPLICATIONS</u>

#### 3.1 DA 544/2220/2015 – Price Boat Club Inc.

Speaker Mr Ron Fairlie objects to the submission and raised the following concerns;

- Currently, weed comes up river on incoming and outgoing tides and dumps on the boat ramp.
- Concerns with the amount of additional weed that may accumulate on the boat ramp as a result of the proposed development structure.
- The weed already presents a current problem with locals having to shovel the weed away for an approximate period of 5 months of the year.
- The current wharf/jetty area has a unique 'heritage' aesthetic; the proposed structure may not be sympathetic to the 'heritage' feel.
- The king tide rises above and exceeds the location of the proposed structure with the water flowing on to the road.
- Concerns with fishing lines being cast across the vicinity of the boat ramp and causing hazards.

Speaker Mr Jim Burgess representing the Applicant, Price Boat Ramp Inc;

- Proposed structure will provide improved accessibility for all in the community to enjoy fishing.
- The current site of the proposed structure is muddy and is unsuitable surface as a fishing platform.
- There is a popular swimming and jet ski recreation area in the vicinity of the proposed platform, the current proposed location of the platform would not obstruct or impede these activities.

That the matter be deferred, pending a site visit to the development location/site and for the Price Boat Club to provide an accurate scaled drawing of the proposed development to the Panel for consideration.
