Local Nuisance and Litter Control Act 2016 Information Sheet 180 – Defence of Due Diligence

The defence of due diligence under the *Local Nuisance and Litter Control Act 2016* (the Act) is a process whereby – in court proceedings against a person for an offence - the person has a valid defence if they can prove to the court that they took all reasonable precautions and exercised all due diligence (care) to prevent the offence occurring.

What circumstances does the defence of due diligence apply?

The defence of due diligence exists in relation to proceedings against a person for an offence under section 18 (causing local nuisance) or 22 (disposing of litter) of the Act. It is a defence to prove that the person took all reasonable precautions and exercised all due diligence to prevent the commission of the offence.

This means that a contravention of the Act by persons involved in any of these activities would be required to prove that they;

- took all reasonable steps to prevent or avoid the circumstances that gave rise to the offence including putting in place any systems or safeguards that might reasonably be expected to be in place
- complied with the requirements of any notice issued under the Act (i.e. nuisance of litter abatement notice)
- as soon as becoming aware of the circumstances that gave rise to the offence they;
- reported the circumstances to the Minister, administering body or relevant council
- took all reasonable steps necessary to prevent or reduce those circumstances.

It is not sufficient however just to state such claims with the expectation that they will automatically mitigate the circumstances of the offence; any claims must be proven in order for them to be accepted as a defence.

A person should not misconstrue a defence of due diligence as being an automatic excuse for proceedings relating to an alleged offence.
