<u>6. TROUBRIDGE ISLAND LIGHTHOUSE CLOSURE – REQUEST FOR FUNDS TO REPAIR/UPGRADE</u> (File Ref: 9.24.1.1)

INTRODUCTION

Council has been approached by Steven Griffiths MP following discussions between himself and Minister Stephen Mulligan on the merits of utilising the \$70K allocated for emergency works for maintenance and repairs and whether the Council and the local community may be willing to contribute towards the repair/upgrade of the Troubridge Island Lighthouse.

RECOMMENDATION A

That Council make a contribution of \$...... to assist with maintenance of the Troubridge Island Lighthouse on the proviso that DPTI guarantee to maintain this State Heritage listed Asset in good order and repair and in a safe condition to allow ongoing use of the facility.

or

RECOMMENDATION B

That Council does not agree to make a contribution at this time.

COMMENT

Council has received correspondence from Steven Griffiths, Member for Goyder, (copy attached) requesting that Council consider providing financial assistance towards repair and/or upgrade of the Troubridge Island Lighthouse.

The Troubridge Island Lighthouse is State Heritage listed and is located in the Troubridge Island Conservation Park. It was decommissioned in 2002 and management of the Lighthouse was transferred to the Minister for Transport. As the current lessee, DPTI is required to keep and maintain the lighthouse in good order and repair and in a safe condition. Although the Lighthouse has no permanent occupation, small groups of the public are shown through the Lighthouse.

After a recent site inspection, DPTI has announced that in the interest of public safety, the Lighthouse will be closed immediately, with \$70,000 of emergency works to be undertaken to ensure this closure. Flaking toxic lead paint and the deteriorating observation deck are two of the major concerns.(Refer YP Country Times article 21 January 2015).

Steven Griffiths has requested that the Minister consider using these funds to repair and/or upgrade the Lighthouse instead of enforcing its closure. The Minister has since responded asking Mr Griffiths to seek local feedback and whether potential contributions can be sourced locally to support this initiative.

Mr Griffiths is seeking support of between \$5,000 and \$10,000 to put toward the repair and/or upgrade of the Lighthouse.

For Councillors information the second quarter budget review is nearing completion and indications are that it will return a positive result of approximately \$120,000 decrease in the revised budget deficit. Dear Minister Mullighan

I refer to the imminent closure of the State Heritage-listed Troubridge Island Lighthouse on Southern Yorke Peninsula, as confirmed with me by your Chief of Staff yesterday and I appreciate the information being provided to me.

Upon reading the briefing note supplied, I understand the lighthouse is to be closed in the interest of public safety due to the presence of toxic flaking lead-based paint on its floors, and potential danger of fragments falling off the observation deck which, as can be seen by the photographs included in the briefing note, is in very poor condition.

Your office has advised public tours of the lighthouse will cease immediately and DPTI is to undertake emergency works, at a cost of \$ 70,000, to mitigate risk which will include locking the lighthouse and replacing the lock strap to the door, and removing the observation deck and handrails.

Interestingly, in contacting an Edithburgh resident who I know is a supporter of works on Troubridge Island, it appears that the volunteer Friends of Troubridge Island group that they are not aware of this decision. I note that the group are encouraged to provide assistance with future conservation of the lighthouse (i.e. assist with painting its exterior), but it appears that DPTI has no funding to assist with any such conservation works.

I raise with you the question of the obligations of the DPTI as the lessee of this Heritage-listed structure managed by the Department of Environment, Water and Natural Resources, which I can only presume requires it be kept and maintained in good order and repair? I am concerned that this lighthouse will be left to crumble and seek your support in funds being provided to the Friends of Troubridge group of volunteers to assist them in their continued efforts to preserve this significant site.

This lighthouse, erected in 1856, is the second oldest remaining lighthouse in South Australia, and "is significant as the only example of a cast iron lighthouse tower in South Australia and one of only a few in Australia" (see enclosed SA Heritage Register documentation for details).

It is a real shame that this structure has been left to deteriorate to such an extent that these emergency works (and public closure) are deemed necessary and, indeed, that the observation deck which is such a significant feature, is to be removed. While the briefing note provided details of the

cost of emergency work, no comparative information on the cost of repair works to site to allow access was given.

Without this information, I am concerned that the \$ 70,000 to be spent could in fact be put towards a longer term thinking of repairing the Lighthouse and an important part of the maritime history of South Australia continuing to be available for viewing.

Thus, I would urge you to seek information from staff about this option and also ask that you provide me with a copy of this information.

In the interest of preservation for future generations, I implore you to ensure further deterioration to this historically significant structure is not allowed to occur.

BACKGROUND

The Troubridge Island Lighthouse (lighthouse) is State Heritage listed and is located in the Troubridge Island Conservation Park (refer Appendix A). The Island is 'moving', and the lighthouse which was once in the centre of the island is now situated on its far north coast.

In March 2002, the Australian Maritime Safety Authority (AMSA) decommissioned the lighthouse after establishing a beacon on the nearby Marion Reef.

The management of the lighthouse was transferred by AMSA to the then Minister for Transport, via a Deed dated the 25th June 2003, whereby the Minister for Transport agreed to perform AMSA's obligations under their lease agreement with the then Department of Environment and Heritage.

As the current lessee, the Department of Planning, Transport and Infrastructure (DPTI) is required, at its own expense, to keep and maintain the lighthouse in good order and repair and in safe condition to the reasonable satisfaction of the lessor, currently the Department of Environment, Water and Natural Resources (DEWNR).

Located adjacent to the lighthouse (2-3m) are two cottages, under the care, control and management of DEWNR. These cottages are leased to Mr and Mrs Johnson who provide accommodation for holiday/tourism purposes.

Although the lighthouse has no permanent occupation, small groups of public are shown through the lighthouse by the cottage lessee.

DISCUSSION

DPTI has recently completed a site inspection and condition report on the lighthouse where several issues of concern were identified, however two are deemed critical:

- The lighthouse should be closed to the public due to the presence of flaking lead based paint on the floors, which is highly toxic.
- The observation deck is in very poor condition. It is brittle and the condition of the deck is such that there is a potential of fragments falling off (refer Appendix B).

In the interest of public safety, DPTI will undertake emergency works to the lighthouse to mitigate this risk, under section 54 of the *Development Act 1993*. DPTI will follow up as soon as possible with a section 49 application with the Development Assessment Commission.

The emergency works (at an estimated cost of \$70 000, excl. GST) will include:

- The lighthouse will be locked and the lock strap to the door will be replaced. No unauthorised access will be allowed.
- The observation deck (excluding the steel corbels) and handrails will be removed and stored appropriately inside the lighthouse (refer Appendix C).

All components will be removed with care; photographed, labelled and catalogued for potential relocation at a later date or replication for future reinstatement. Advice will be sought from a Heritage Conservationist prior to any removal and storage works.

The works are scheduled to commence early December 2014 subject to approval. Programmed repairs to the Granite Island screwpile jetty landing will be deferred to 2015-16 to fund the project.


Discussions have been held with DEWNR, the Heritage Unit of DPTI, and Mr Johnson (also associated with the Friends of Troubridge Island). Mr Johnson has been formally advised in writing, as all public access and tours of the lighthouse are to cease immediately.

Volunteers and Friends of Troubridge Island have undertaken conservation works on the island in the past. On completion of the emergency works, these groups may insist on conserving the lighthouse, by painting the exterior.


Conservation works can only be done when a conservation management plan is complete and all issues including liability, funding, detailed scope of works, consultation and development approval have been resolved. DPTI has no funding to undertake conservation works on the lighthouse.

Funds have been made available for this urgent by delaying other planned work.



TROUBRIDGE Island lighthouse, off the coast of Edithburgh, sits on shifting sand and has battled the forces of nature for 159 years.

Heritage-listed lighthouse's biggest threat may come from the people charged with protecting and maintaining it.

The Department of Plan-

ning, Transport and Infrastructure owns the cast-iron tower but Chris and Judy Johnson have been the unofficial custodians of the island and its infrastructure since leasing the cottages in 1993.

The deck, weighing about three tonne, has been placed on the wooden floor inside the tower.
