Road Closure - West Coast Road Corny Point



29th May 2013

District Council of Yorke Peninsula

Background

Council received a letter dated the 8th March 2013 from the Department of Environment, Water and Natural Resources (DEWNR) asking Council to initiate the road closure process for the portion of West Coast Road between Wurlie and Gleesons Road, Corny Point.

This road is located through an area that is intended to be proclaimed as a Conservation Park under the National Parks and Wildlife Act 1972, with the proposed name 'Thidna Conservation Park'.

The DEWNR's intention is that the closure of the road will be followed by the submission of a plan of division and the proposed vesting of the land with Council.

The proposed draft plan of division to be lodged after the road closure includes the following proposal;

Allotments 100 & 102 are to be proclaimed as Thidna Conservation Park, pursuant to the National Parks and Wildlife Act 1972.

Allotment 101 to be allocated as freehold to Mr Shepley who currently owns the parent Section 20 Hundred of Carribie Certificate of Title 5928/683.


Allotment 103 to be an enlargement of the existing Foreshore Reserve, Allotment 9, DP 44261, Crown Record 5339/218, under the care, control and management of Council. The extension of the Coastal reserve is in order to accommodate overflow of parking associated with the boat ramp and pedestrian access. It is undesirable for this area to be included in the park because of the denigration caused by vehicles.

Allotment 104, which contains a bore and a water pump, is proposed to be a Water Reserve under the care, control and management of Council.

The road for the proposed closure has been identified as an alternative to the beach for cyclists and walkers of the Walk the Yorke project for when the tide is in along the stretch of coast adjacent to the road in question.

For this reason the DEWNR envisage a track would still be accessible across the proposed Thidna Conservation Park with the existing track servicing the bore for the southern portion and the remainder of the track being at the edge of the existing sand hills.

Notice is hereby given pursuant to Section 10 of the Roads (Opening and Closing) Act 1991, that the District Council of Yorke Peninsula proposes to make a Road Process Order to close and vest the following in the Crown:-

The whole of the public road West Coast Road situated between Wurlie and Gleesons Roads and adjoining Section 21 Hundred of Carribie, and Allotment 1 (Deposited Plan 30408), more particularly delineated and lettered 'A' and 'B' (respectively) on Preliminary Plan No. 13/0018.

A copy of the plan and statement of persons affected is available for public inspection at the Maitland, Minlaton, Yorketown and Warooka Council offices, on Council's website at www.yorke.sa.gov.au and the office of the Surveyor-General, Level 1, 101 Grenfell Street, Adelaide SA during normal office hours.

Any applications for easements or objections must be made in writing with fully supported reasons, full name, address and details of the submission WITHIN 28 DAYS OF THIS NOTICE, and must be sent to Mr Andrew Cameron, Chief Executive Officer, District Council of Yorke Peninsula PO Box 88 Minlaton SA 5575 with a copy forwarded to the Surveyor-General, GPO Box 1354 Adelaide SA 5001.
