CONDITIONS OF USE FOR A VEHICLE LICENSED FOR THE SALE OF FOOD/GOODS

The issue of this permit is subject to:

1. The applicant agreeing to the general conditions of the permit as contained therein.
2. The applicant agreeing to any special conditions which the Authority determines and are attached hereto.
3. If this permit relates to the sale of food, the following applies:
 - The vehicle shall be maintained in a clean and roadworthy condition and in accordance with the Food Act regulations at all times.
 - The vehicle is not used for any other purposes which would be likely to contaminate or injuriously affect the wholesomeness or cleanliness of the food.
4. A copy of the licence being carried in the vehicle and produced to a Council Officer on request.
5. Persons selling on a public place other than a street or road shall:
 - (a) Place no advertising signs in the area.
6. The vehicle shall be operated in accordance with the provisions of the Local Government Act, Food Act and/or Council By-Laws in such a manner as not to create a nuisance **NAMELY**:
 - Any person shall not without the consent of the Council in any street, road, or public place, amplify or reproduce for the purpose of making any announcement or advertisement, any words or other sounds by means of any apparatus or device, whether electrical, mechanical, or any other kind whatsoever.
 - Any mobile vendor cannot linger, loiter or occupy any fixed stand on any council land but must, except when actually serving a customer, keep moving at a walking pace of not less than 2 kilometres per hour and cannot travel the same route more than once during the period of one hour.
 - Any person who offends against these provisions shall be guilty of an offence and liable to a penalty not exceeding seven hundred and fifty dollars (\$750).

The Council hereby consents to the use of amplified music on the vehicle subject to the following conditions:

- (a) The chimes must not exceed 60 dB(A) when measured at 7 metres from the unit.
 - (b) The operator must not use the chimes except between the hours of 9.00 am and sundown.
 - (c) The chimes must not be used when the vehicle is stationary.
 - (d) The chimes must not be used for more than two minutes on any one occasion.
 - (e) The chimes may not be used more frequently than once within any 10 minute time period.
7. The applicant shall take out and keep a current Public Liability Insurance policy in the name of the applicant, insuring the applicant for the minimum sum of ten million dollars (\$10,000,000) against all actions, costs, claims, damages, charges and expenses whatsoever, which may be brought, made or claimed against the applicant in relation to the activity.

NB:- A copy of the Certificate of Currency for Public Liability Insurance must be provided with application.
